The chairman, Board of Studies, may with the approval of the principal of the college, co-opt:

- Experts from outside the college whenever special courses of studies are to be formulated
- Other members of staff of the same faculty.

II. Term:

The term of the nominated members shall be two years.

III. Meeting:

The Principal of the college shall draw the schedule for meeting of the Board of Studies for different departments. The meeting may be scheduled as and when necessary, but at least once a year

IV. Functions:

The Board of Studies of a department in the college shall:

- Prepare syllabi and various courses keeping in view the objectives of the college, interest of the stakeholders and national requirement for consideration and approval of the Academic Council.
- Suggest methodologies for innovative teaching and evaluation techniques;
- Suggest panel of names to the Academic Council for appointment of examiners; and
- Coordinate research, teaching, extension and other academic activities in the department/college.
