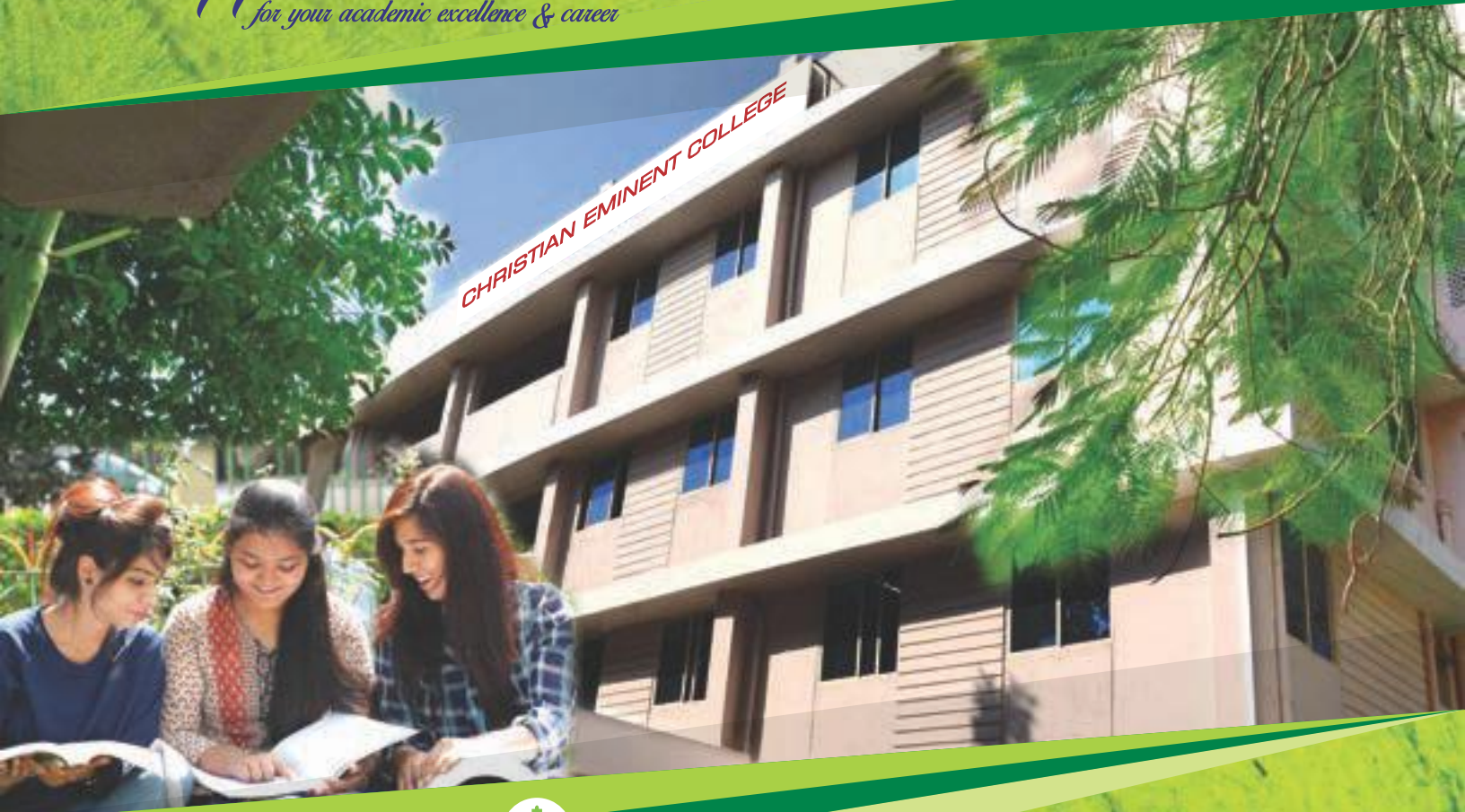

The Institute

Christian Educational and Cultural Society a voluntary non-profit organization, registered under M.P. Society Registration Act. 1973, established Christian Eminent College in 1996, in fulfillment of the solemn desire of the founders to provide quality; value based and professional education in the area of Management, Computer Science, Information Technology, Biotechnology, Commerce, Education and other emerging disciplines. The College has the approval of Govt. of M.P., NCTE and is permanently affiliated to Devi Ahilya Vishwavidyalaya, Indore and also recognized under section 2(f) & 12(B) of UGC and reaccredited with "A" Grade of NAAC, UGC. The college was conferred AUTONOMOUS STATUS and later EXTENSION of it for a period of next six years by the University Grant Commission. Catering to the growing need for tech savvy managers in the liberalized Indian industrial environment, the college has blossomed into a premier institution in the field of professional education. It has charted phenomenal growth since its inception by launching novel professional courses in emerging disciplines having good job potential. As per the UGC guidelines the college has implemented CBCS System and looking to the current needs, various Skill Enhancement Courses have been introduced as a part of course curriculum.

Christian Eminent College has excellent infrastructural facilities in the form of spacious classrooms, laboratories, library, a spacious hall for indoor games as well as conduction of various activities, a large play ground for various outdoor games and sports. The College takes pride in having a team of highly qualified, experienced and dedicated faculty and friendly administrative staff.

The College is located in the heart of the city of Indore. It has two spacious campuses in close proximity of each other with beautiful surroundings. Campus No. 1 is located at Ravi Shankar Shukla Nagar, Main Road; Campus No. 2 is located nearby in the Press Complex, Indore, both having close proximity with busy A.B. Road, the National Highway. The L.I.G. crossing is the nearest point to arrive for the newcomers. Distance between the College and Railway/Bus station is 5 kms. and Airport is about 10 kms. In addition to the above two academic campuses, the college also has its own playground for games and sports facilities developed in three acres at Tulsi Nagar.

A Special Status

The UGC Document on the 12th plan profile on higher education in India highlighted the importance of autonomous colleges, clearly stating that, "The only safe and better way to improve the quality of education is to promote the autonomous colleges. Colleges with academic and operative freedom are doing better and have more credibility." The Education Commission (1964-66) had recommended college autonomy, which, in essence, is the instrument for promoting Academic Excellence. The National Policy on Education (1986-92) formulated the objectives for Autonomous Colleges, such as, freedom in curriculum and other academic activities, examination and evaluation process etc. The autonomy is given to only those colleges that have excellent academic, cultural, sports, other co-curricular and administrative record, state-of-the-art infrastructure, research activities and, above all, minimum ten years of its existence, and after the verification of the mentioned facts by UGC's high-power Committee. The UGC and DAVV, with all their necessary conditions, were in agreement for autonomy to be conferred on Christian Eminent College and then awarded Autonomous Status in the year 2010 for a period of six years. Later, after the close observation of academic and other attainments UGC awarded Extension of Autonomous Status for a period of next six years from session 2016-17 to 2022-23. With the privilege of autonomous status the college accelerate excellence in all its academic programmes, examination system and other activities. Results are declared on time and everything took place as per the college calendar.

The leadership and governance of the college is based on the principle of participatory, democratic and transparent approach. All the members of College Governing Body are from academic sphere. The President of Foundation Society Prof. M. H. Meer himself is from academic world and was a former Professor and Head, Department of English at Government Autonomous Holkar Science College, Indore which has a glorious history of more than 125 years of its establishment. The College Director retired from the same Government Autonomous Holkar Science College, Indore as Professor and Head. After his retirement, he was nominated by the State Government in the Governing Body of the same college as Chairman. It's a matter of pride that Vice Chancellors of two state Universities have also been associated with the College Governing Body. Some other members are senior educationists of reputed institutions of the city and are also associated with NAAC as members of NAAC Peer Teams for accreditation process of various institutions of the country.

Examination Cell

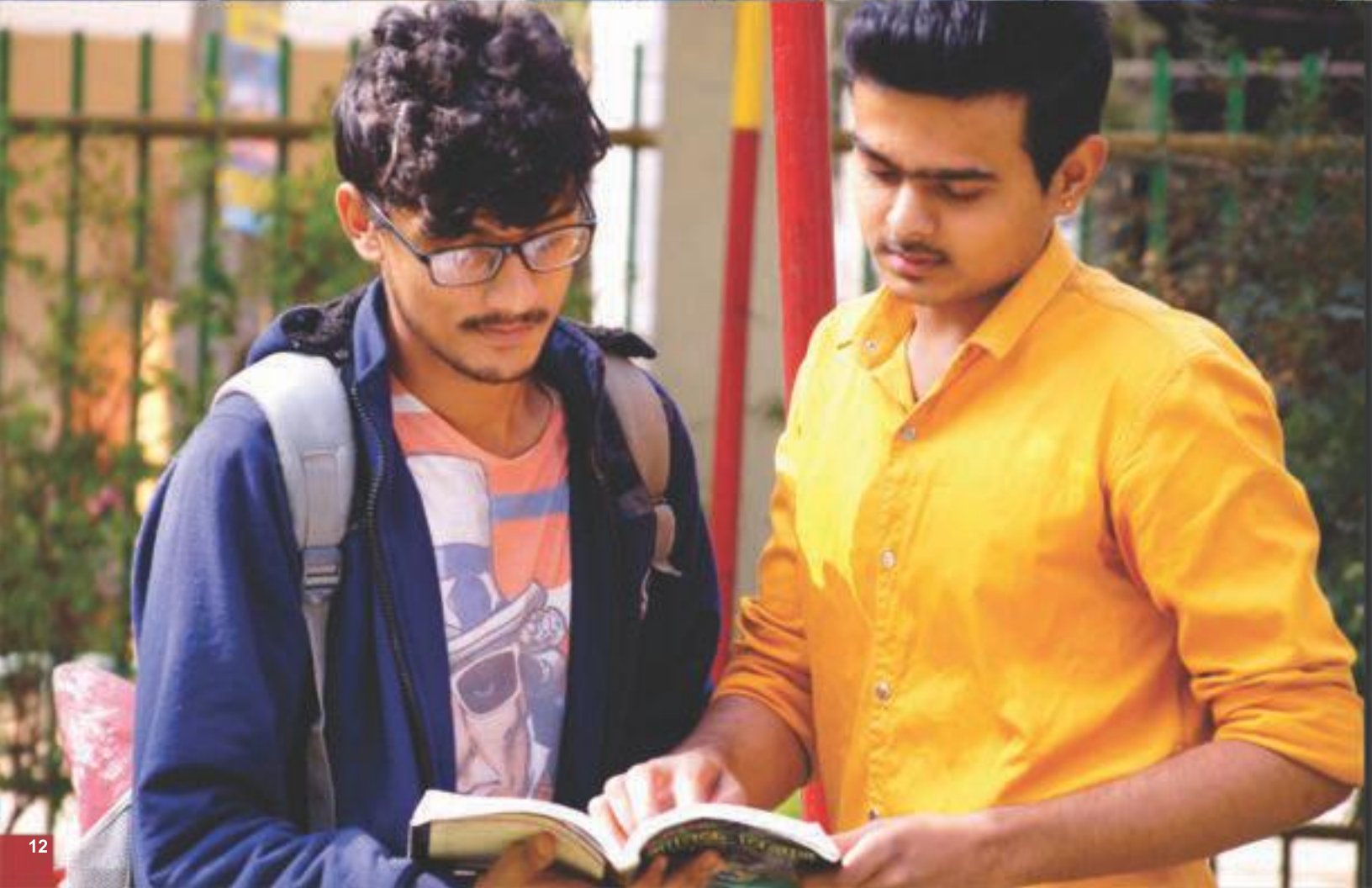
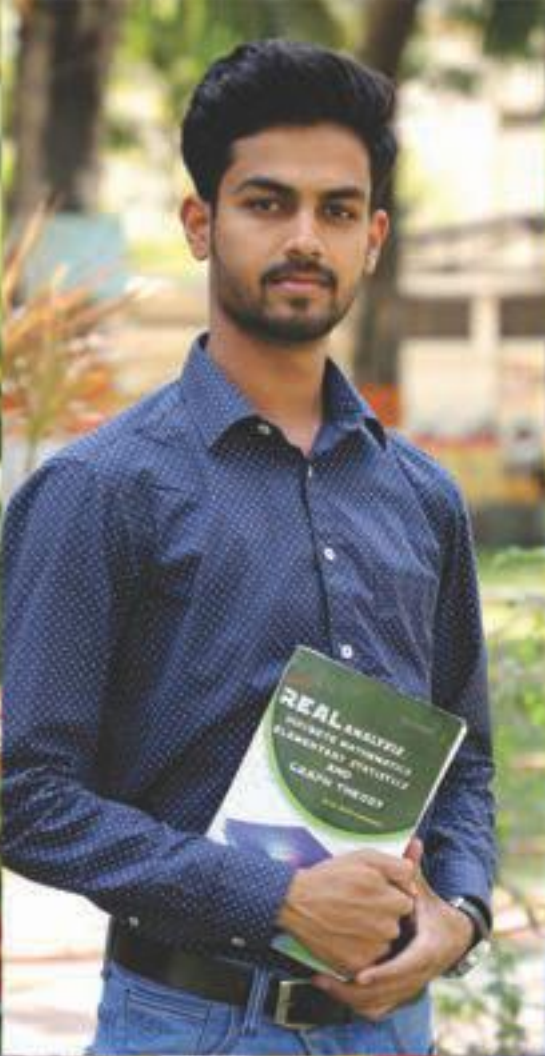
With the award of AUTONOMOUS STATUS as per UGC norms its own Examination Cell was established in the College. It is a matter of pride that due to the efficient and transparent functioning of this cell, all the examinations are conducted smoothly and timely with the student, feeling fully satisfied and exultant. Also, the examination results are declared as per schedule and in time so that the students are able to understand their positions well before the commencement of the next semester session. The academic calendar, too, is made known at the beginning of the semester enabling the students to know the date wise activities for the entire semester. The students' performance is evaluated on the basis of Internal and External Examinations. The Internal Academic Performance of the student is continuously evaluated through internals: CCE, assignments, practicals, project work, seminars, etc., and the students are required to submit all the assigned work in due time period to the respective faculty of the Department. The External Evaluation is carried out in the form of Semester Examinations that are conducted at the end of every semester.

After the completion of Internal/External evaluation, the Examination Cell prepares the Final Results and after countersigned by the Devi Ahilya University, Indore, the results are declared and they are at once displayed ONLINE on the college Website so that the students can know their results immediately. All the examination related activities, from the submission of examination forms till declaration of results, are completely online. All these activities related to examinations are conducted successfully by the Examination Cell comprising Controller, Deputy Controllers and other associate staff. The entire process is carried out in a separate building/rooms having accommodation for Controller, Deputy Controllers, Valuation In-charge, Valuation work, Storage of examination materials and all other related work.

Internal Quality Assurance Cell (IQAC)

The Internal Quality Assurance Cell (IQAC) has been established in the College at the instance of the National Assessment and Accreditation Council (NAAC) for quality sustenance measures. The Cell ensures continuous improvement in the entire operations of the College and it also assures stakeholders connected with higher Education, namely parents, teachers, staff, would be employers, agencies and society in general, of its own quality and probity. The formation of the IQAC is as per the UGC and NAAC norms. There are external members in it as prescribed in the guidelines of NAAC, and they are eminent persons in their respective fields. At present, in IQAC, two senior and reputed persons of the affiliating university are members, in which one, Dr. Ashutosh Mishra, is a former Vice Chancellor of the university. The other member, Dr. Ashok Sharma is a renowned professor of chemical science in the university and is also involved in NAAC Accreditation Process of various institutions. Dr. Sunanda Jain is a leading and senior gynaecologist in the city and was associated with the affiliating university as a member of its Executive Council. Industry persons, former and present students and persons from local community are also part of IQAC. They all have significantly contributed towards the growth of the college by giving their valuable suggestions and guidance.

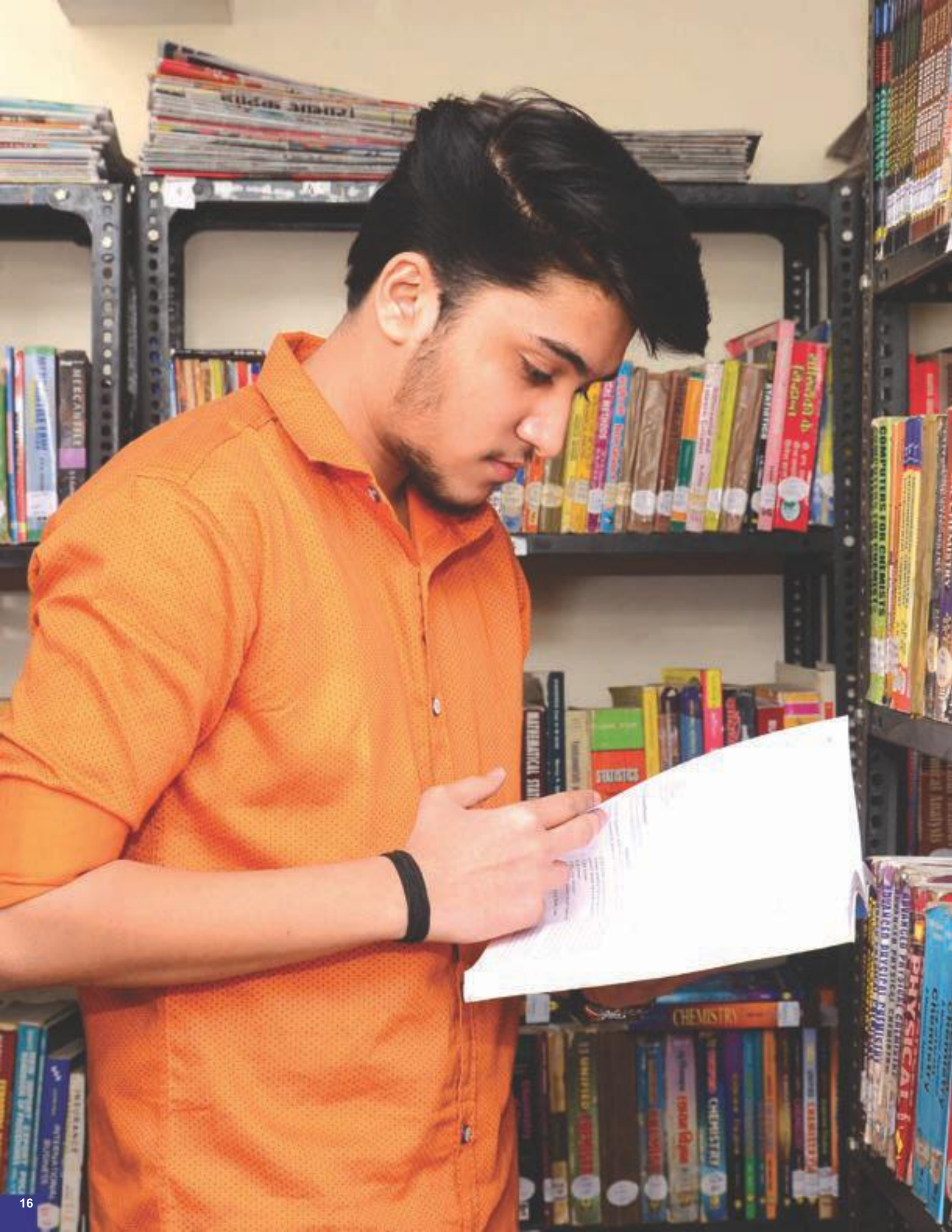
Bioscience Laboratory

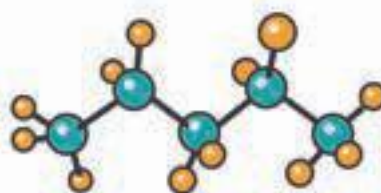
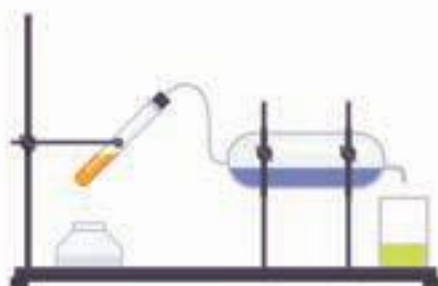

Admission Procedure



ADMISSION PROCEDURE: Admission to all the courses would be made in order of merit determined on the basis of percentage of marks obtained by the student in the qualifying examination and the component of group discussion and/or personal interview. The candidate is advised to apply for admission only if he/she is sure that he/she fulfils the eligibility requirements for the particular programme for which he/she is seeking admission. It is the responsibility of the student to obtain all the relevant information about his/her eligibility. In case a student who is provisionally admitted on the basis of the information/documents furnished by him is found ineligible, due to 'any reason, the Director/Principal can cancel his/her admission.

Application Form complete in all respects, should be submitted with the following documents attached:

1. School/College Leaving Certificate (T.C./S.L.C./C.L.C.) of the previous school/college attended in original.
2. Two attested photocopies of marksheets of X, XII and/or qualifying examination.
3. In case there is a gap in the education of the candidate, he/she must submit a Gap Certificate indicating that he/she has not taken admission in any College, has not appeared for any Examination and that his/her conduct has been good.
4. Students who have not passed XII from Madhya Pradesh Board or graduated from Devi Ahilya Vishwavidyalaya must submit eligibility certificate from Devi Ahilya Vishwavidyalaya, Indore and a migration certificate from the previous Board/University.

NOTE

1. One who has appeared in the qualifying examination during current year as a regular or private candidate but whose result is yet to be declared can also apply for admission on provisional basis. Such a candidate must produce the certificate of passing the examination before the last date fixed for this purpose, otherwise his admission will be cancelled. The fee and charges paid by him shall not be refunded in any case.
2. Minimum intake of 50% of total seats is essential to start a programme.

RULES FOR ADMISSION

1. Only students who have passed class XII can seek admission to Graduate programmes. Students, who have to appear in Supplementary Examination to pass class XII or final year of degree course, are not eligible to seek admission unless permitted by the M.P. Govt. and the University.
2. Students who have to appear for A.T.K.T. Examinations in Ist or IInd year must take provisional admission to the higher class.
3. Regular and Provisional Admission in Post Graduate programmes will be as per the University/College rules for the particular programme.

Rules & Regulations

- Those students who are not previously enrolled with the University must submit the enrollment form along with admission form. Those who are already enrolled must mention their enrollment no. on the admission form.
- Decision of the Director/Principal with respect to admission shall be final.

RESERVATION : In the matter of reservation of seats, the College follows the provisions contained in the constitution of India and the decision of Supreme Court of India as applicable to self-financing educational institutions established and administered by MINORITY COMMUNITY.

FREESHIP : Admission to candidates belonging to economically weaker section of the society will be in addition to stipulated seats to the maximum extent of 5% provided they have obtained prescribed marks at the qualifying examination. Such candidates may be granted exemption from payment of tuition fee prescribed for the course up to the maximum extent of 100 % depending upon the merits of each case. If more than one child of the same parents is studying in the College the younger of the two may be granted 50% concession in the tuition fee subject to his passing the examination in one attempt and possessing good conduct.

REFUND OF FEE : If a student is granted admission to any of the academic programs conducted by the College and deposits the fee in full or part, but subsequently does not join the course, or leaves the course at any time during the Year / Semester due to any reason whatsoever, his/her fee will not be refunded.

Similarly, **late fee will be charged**, if the student fails to pay the regular/ normal installments of fee by or on the last date prescribed.

ISSUE OF COLLEGE LEAVING CERTIFICATE : College leaving Certificate (C.L.C.) will be issued to a student only after completion of the concerned course in which he has been granted admission and clearance of all dues towards the College. Any request for issue of C.L.C. in mid session will not be entertained: Nevertheless students making such request will have to show reason to the satisfaction of the College authorities, and is supported by written consent of the parents. In such cases, if issue of C.L.C. is sanctioned, the concerned student will be required to pay the balance fee and dues for the whole session. Also the student should produce original documents and receipts as required by the College.

DISCIPLINE AND CODE OF CONDUCT : We value self-discipline and do not believe in policing. We have a lot of trust and faith in our students. We want students to live up to that trust. Students are required to observe the code of conduct prescribed by Devi Ahilya Vishwavidyalaya, and the College from time to time. Violations of the Instructions/ code of conduct and/or any behavior unbecoming of the College student will invite strict disciplinary action including fines, suspension, debarment from examinations, and expulsion from the College etc. Students are expected to be courteous and

friendly towards their fellow students. They should conduct themselves in a manner, which is conducive to promotion of healthy cooperative life.

- > Possession of objectionable articles such as firearms, sharp or blunt weapons of any kind, obscene literature or paintings etc. in the College campuses are strictly prohibited.
- > Damage to equipments and fixtures, and absenteeism will attract heavy deterrent fines besides disciplinary action.
- > Smoking, use of alcohol, chewing gum or gutka or tobacco, and use of mobile phones and use of polythene is strictly prohibited in the College Campuses
- > Students are not allowed to paste or circulate notices, pamphlets, posters, etc. in the College Campuses without prior permission from the Principal/Director. Students are also forbidden to invite any outsider to the College directly.
- > RAGGING or harassment of newly admitted/junior students is STRICTLY PROHIBITED. Any student found indulging in it is liable for expulsion from the College as well as criminal prosecution.

ATTENDANCE : Courses of professional nature requires a high degree of involvement, hard work and punctuality on the part of students. Indolent and indisciplined students have no place in the College. As per M.P. Govt. & University rules 75% attendance is compulsory in class/practical sessions, Students who do not fulfill the requirement of 75% attendance subject to restricted condonation for participation in University level co-curricular activities, may be debarred from appearing in the examinations. Holidays/Vacations will be as per the State Government/University orders.

EXAMS: B.Sc., B.Com. and B.Com. (Hons.) courses have Annual System and the final main examinations are conducted in the month of March-April. All the other courses have Semester System and the end-semester examinations are conducted in the months of Nov-Dec and April-May of every academic session. To appear in the respective examination, the student must submit the filled examination form along with the requisite examination fee by the prescribed dates.

The students must also deposit all the three installments (at the time of admission, First week of October, and First week of next January) of the college fee. Otherwise, they will not be allowed to appear in the examinations.

To pass a semester-end examination, it is compulsory for a student to pass separately and individually also in all the three examinations i.e. internal, practical (if applicable) and theory examinations.

For detailed rules, regulations and information students may contact the Examination Cell.

JURISDICTION : In case of any dispute regarding admission to or conduction of any course or payment or refund of fee or any other matter concerning the activities of the College, the jurisdiction will be that of courts of Indore only.

Training & Placement Cell

TRAINING & PLACEMENT CELL: The academic rigor of the future leaders is made complete through the placement activities that introduce them to the corporate world. To fulfill the career needs of students, the College has a **Training & Placement Cell**, which comprises a Training & Placement Officer, Faculty Members and the Students. The functions of placement cell are as under:-

REGULAR INDUSTRY - INSTITUTE INTERACTION: The Training & Placement Cell is mainly responsible for establishing regular contacts with various organizations and industries. The Cell acts as an interface between students, faculty and corporate world to initiate continuous interaction with industry, sharing the industry experiences, understanding the needs of Industry and giving the required support to the corporate world. The Cell remains in constant touch with the corporate job market.

ARRANGEMENTS OF INTERVIEWS: The Placement Cell arranges **ON CAMPUS** and **OFF CAMPUS INTERVIEWS** for the students by the prospective employers. Job Fairs are also conducted. The Recruiting Companies are required to give a **Pre-Placement Talk (PPT)** before starting the selection process in the College Campus. The objective of **PPT** is to provide the students an opportunity to understand the organization, and to the recruiting company to highlight its requirement and careers it is offering to the students. The Institute provides necessary facilities to companies for conducting tests and campus interviews for final placement. During the previous sessions a number of well-known companies visited the College for campus recruitments and Off-Campus Interviews were also conducted by them. The College is grateful to all the corporates for recruiting our students in increasing numbers.

PERSONALITY DEVELOPMENT PROGRAM: A sound personality in all respects brings success to a student's life. Cognizant of this requirement the College offers a unique and invigorating program on **Personality Development** which is being very well received in the whole academic and professional areas. The NATIONAL ASSESSMENT AND ACCREDITATION COUNCIL (NAAC) is an autonomous body established by the University Grants Commission (UGC) of India to assess and accredit institutions of higher education in the country. It is an outcome of the recommendations of the National Policy in Education (1986) which laid special emphasis on upholding the quality of higher education in India. To address the issues of quality, the National Policy on Education (1986) and the Plan of Action (POA-1992) advocated the establishment of an independent national accreditation body. Consequently, the NAAC was established in 1994 with its headquarters at Bangalore.

Assessment and Accreditation is broadly used for understanding the "Quality Status" of an institution. In the context of Higher Education, the accreditation status indicates that the particular Higher Educational Institutions (HEI) – a College, a University, or any other recognized Unit therein, meets the standards of quality as set by the Accreditation Agency, in terms of its performance, related to the educational processes and outcomes, covering the curriculum, teaching-learning, evaluation, faculty, research, infrastructure, learning resources, organization, governance, financial well being and student services.

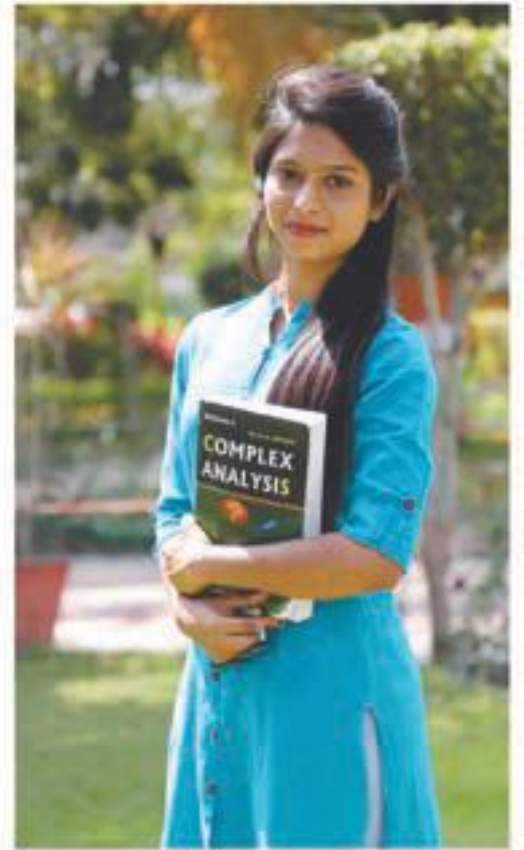
